Know all men by these presents that I, Jonathan Condit of the Township of Newark in the County of Essex & State of new Jersey being of sound memory & recollection & with my xxxx of my property do make this my last will & testament in main is following:

First I give to my wife Jemima a good Horse & Cow, bed & bed my household furniture sufficient to keep house & any room in my house she shall choose & in other respects I leave her to be provided for as the Law directs.

2 I give to each of my daughters, Jane, Ruth, Rachel & Phebe twenty-five dollars each---to be paid by my Sons equally; & my will is that all my just debts be paid by my sons equally also.

3 The residue of my Estate both real, & personal I give & divide equally between my four Sons, Isaac, Simon, Jonathan & Jeptha, except my Corn Mill, which I give to Jonathan. My will further is, that each of my Sons shall take his part most convient to their respective houses & in the division respect shall by had to the quantity & quality of the law.

Xxx of any difference of opinion exists in making the division, my will is that two or more honest & judicious xxxx be called in to divide the family that al;l matters may be settled in peace & fellowship. Lastly I appoint my four sons above named Executors of this my last will & testament. In Witness whereof I have hereunto set my hand & seal this twelfth day of June in the Year of our Lord Eighteen hundred & five.
